**ANNOUNCEMENT TO SHAREHOLDERS OF PT INDO KORDSA TBK (the "Company")
REGARDING DISTRIBUTION OF THE COMPANY'S INTERIM DIVIDEND FOR
FINANCIAL YEAR 2024**

Perseroan dengan ini mengumumkan kepada seluruh Pemegang Saham Perseroan bahwa berdasarkan Keputusan Dewan Komisaris dan Direksi pada tanggal 11 November 2024, telah memutuskan dan menyetujui pembagian Dividen Interim untuk tahun buku 2024, sebesar Rp 200, - (dua ratus rupiah) per saham ("**Dividen Interim**") kepada pemegang saham Perseroan yang nama-namanya tercatat dalam daftar pemegang saham Perseroan pada tanggal 22 November 2024 pukul 16:00 Waktu Indonesia Barat.

*The Company hereby announces to all Shareholders of the Company that based on the Resolution of the Board of Commissioners and Board of Directors dated November 11th, 2024, has decided and approved the distribution of the Interim Dividend for the financial year 2024, for Rp 200,- (two hundred rupiah) per share ("**Interim Dividend**") to the shareholders of the Company that are listed in the Company's register of Shareholders as of November 22nd, 2024 at 16:00 Western Indonesia Time.*

Tata Cara Pembayaran Dividen Interim

Interim Dividend Payment Procedure

1. Dividen Interim akan dibagikan kepada pemegang saham yang namanya tercatat dalam Daftar Pemegang Saham Perseroan

1. *Interim dividend will be distributed to Shareholders whose names are listed in the Company's register of Shareholders*

(*recording date*) pada tanggal 22 November 2024 sampai dengan pukul 16.00 WIB dan/atau pemilik saham Perseroan pada Sub Rekening efek di PT Kustodian Sentral Efek Indonesia ("**KSEI**") pada penutupan perdagangan saham Perseroan di Bursa Efek Indonesia pada tanggal 22 November 2024.

2. Bagi pemegang saham yang sahamnya dimasukkan dalam penitipan kolektif KSEI, pembayaran Dividen Interim akan dilaksanakan melalui KSEI dan akan didistribusikan ke masing-masing rekening di Perusahaan Efek dan atau Bank Kustodian pada tanggal 5 Desember 2024. Bukti pembayaran Dividen Interim akan disampaikan oleh KSEI kepada pemegang saham melalui Perusahaan Efek atau Bank Kustodian dimana pemegang saham membuka rekeningnya. Sedangkan, bagi pemegang saham yang sahamnya tidak dimasukkan dalam penitipan kolektif KSEI, pembayaran Dividen Interim akan ditransfer ke rekening pemegang saham.
3. Bagi pemegang saham warkat yang menginginkan pembayaran dividen melalui transfer ke rekening, dapat menyampaikan nama dan alamat bank serta nomor rekening atas nama pemegang saham secara tertulis di atas materai disertai dengan salinan kartu identitas yang masih berlaku dan sesuai dengan alamat yang tercantum dalam Daftar Pemegang Saham. Permohonan tersebut dapat disampaikan kepada Biro Administrasi Efek ("**BAE**") Perseroan, yaitu: PT EDI Indonesia, Wisma SMR, Lantai 3, Jl. 4. Dividen Interim tersebut akan dikenakan pajak sesuai dengan peraturan perundang-undangan perpajakan yang berlaku. Jumlah pajak yang dikenakan akan menjadi tanggungan Pemegang Saham yang bersangkutan serta dipotong dari jumlah Dividen Interim yang menjadi hak Pemegang Saham yang bersangkutan.

(*recording date*) as of November 22nd, 2024, until 16.00 WIB and/or the Shareholders that are registered in the Securities Sub Accounts of PT Kustodian Indonesian Stock Exchange ("**KSEI**") on the stock trading closing time at Indonesia Stock Exchange on November 22nd, 2024.

2. For Shareholders whose shares are deposited in KSEI's collective custody, the payment of Interim Dividend will be made through KSEI and will be distributed to each account within the Securities Company and/or Custodian Bank on December 5th, 2024. Proof of Interim Dividend payment will be delivered by KSEI to Shareholders through the Securities Company or Custodian Bank where the Shareholders open their accounts. Meanwhile, for Shareholders whose shares are not deposited in the collective custody of KSEI, the Interim Dividend payment will be transferred to the account of the Shareholders.
3. For scrip shareholders who wish to receive the dividend payment via account transfer are required to provide the bank name and address, and the account number in the shareholder's name, in writing, with duty stamp, along with a copy of a valid identity card that matches the address on the Shareholders' Register. The request should be submitted to the Company's Securities Administration Bureau ("**BAE**") at the following address: PT EDI Indonesia, Wisma SMR, 3rd Floor, Jl. 4. The Interim Dividend will be imposed to tax in accordance with the applicable tax laws and regulations. The amount of tax imposition will be borne by the relevant Shareholder and deducted from the amount of Interim Dividend that becomes the right of the relevant Shareholder.

5. Bagi Pemegang Saham yang merupakan Wajib Pajak Dalam Negeri yang berbentuk badan hukum yang belum mencantumkan Nomor Pokok Wajib Pajak (NPWP) diminta menyampaikan NPWP kepada KSEI atau BAE Perseroan, paling lambat pada tanggal 22 November 2024 pada Pukul 16.00 WIB, tanpa pencantuman NPWP, Dividen Interim yang dibayarkan kepada Wajib Pajak Dalam Negeri tersebut akan dikenakan PPh sebesar 30%.
6. Bagi Pemegang Saham yang merupakan Wajib Pajak Luar Negeri yang pemotongan pajaknya akan menggunakan tarif berdasarkan Persetujuan Penghindaran Pajak Berganda (P3B) wajib memenuhi persyaratan pasal 26 Undang-Undang Pajak Penghasilan No. 36 Tahun 2008 serta menyampaikan Form DGT-1 atau DGT-2 yang telah dilegalisasi Kantor Pelayanan Pajak Perusahaan Masuk Bursa kepada KSEI atau BAE paling lambat pada tanggal 22 November 2024 tanpa adanya dokumen dimaksud, Dividen Interim yang dibayarkan akan dikenakan PPh pasal 26 sebesar 20%.
7. Bagi pemegang saham yang sahamnya dalam penitipan kolektif KSEI, bukti pemotongan pajak dividen dapat diambil di perusahaan efek dan/atau bank kustodian dimana pemegang saham membuka rekening efeknya dan bagi pemegang saham warkat diambil di BAE mulai Januari 2025.
8. Pengumuman terkait dengan pembagian Dividen Interim ini dilakukan dalam rangka untuk memenuhi Peraturan Otoritas Jasa Keuangan No.31/POJK.4/2015 Tentang Keterbukaan atas Informasi atau Fakta Material oleh Emiten atau Perusahaan Publik.
5. *For Shareholders who are Domestic Taxpayers in the form of legal entities that have not included a Taxpayer Identification Number (NPWP) are requested to submit their NPWP to KSEI or the Company's BAE, no later than November 22nd, 2024, at 16.00 WIB, without the inclusion of NPWP, the Interim Dividend paid to the Domestic Taxpayer will be imposed to Income Tax of 30%.*
6. *For Shareholders who are Foreign Taxpayers whose tax deduction will use the rate based on the Double Taxation Avoidance Agreement (P3B) must comply with the requirements of Article 26 Law No. 36 of 2008 on the Income Tax and submit DGT-1 or DGT-2 Form which has been legalized by the Tax Service Office for Listed Companies to KSEI or BAE no later than November 22nd, 2024 without the said documents, the Interim Dividend paid will be imposed to Income Tax of 20% as constituted on Article 26.*
7. *For Shareholders whose shares in KSEI's collective custody, proof of dividend tax deduction can be obtained at the securities company and/or custodian bank where the Shareholders opened their securities accounts and for scripted Shareholders, it can be obtained at BAE starting January 2025.*
8. *The announcement related to the distribution of the Interim Dividend is made to comply with the Financial Services Authority Regulation No.31/POJK.4/2015 concerning Disclosure of Material Information or Facts by Issuers or Public Companies.*
